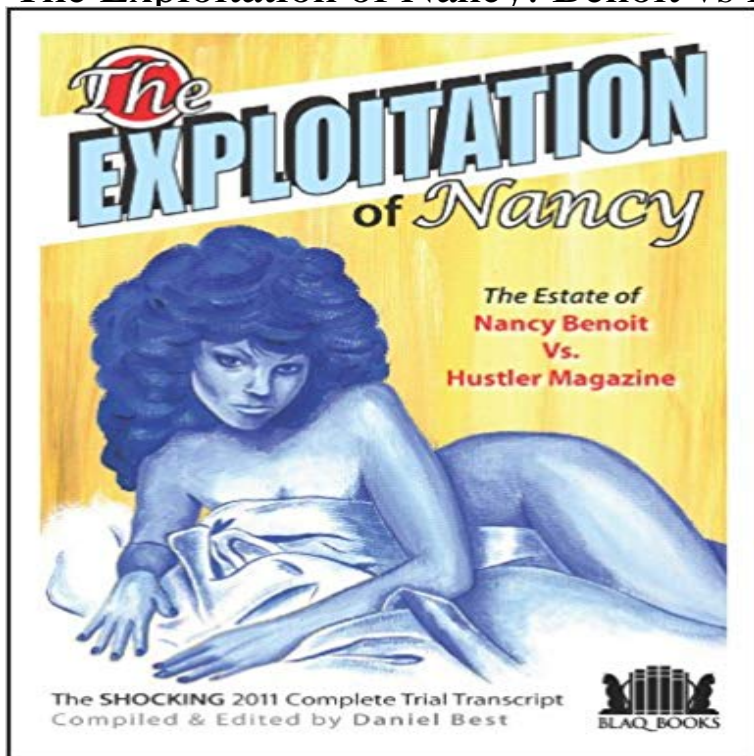


## The Exploitation of Nancy: Benoit vs Hustler
