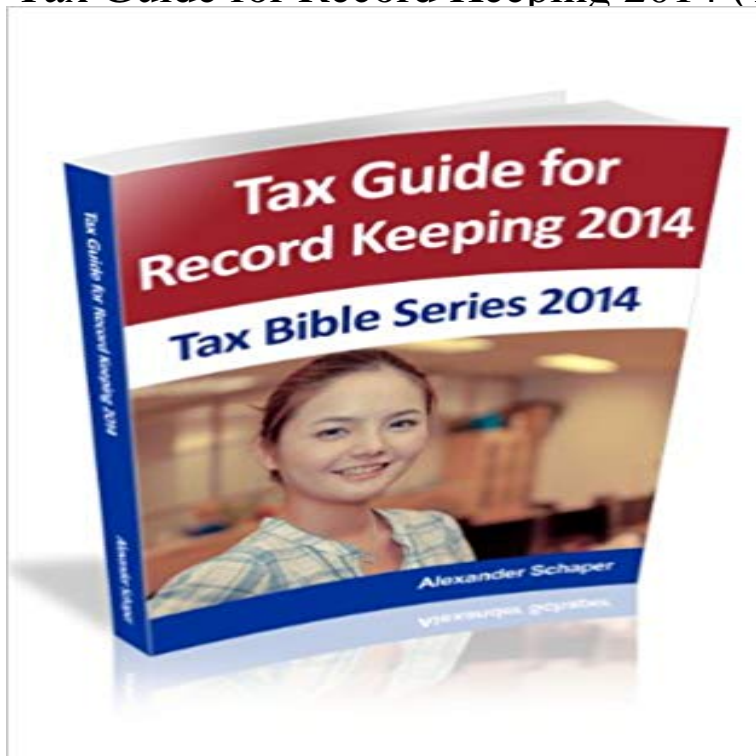


Tax Guide for Record Keeping 2014 (Tax Bible Series 2014)
