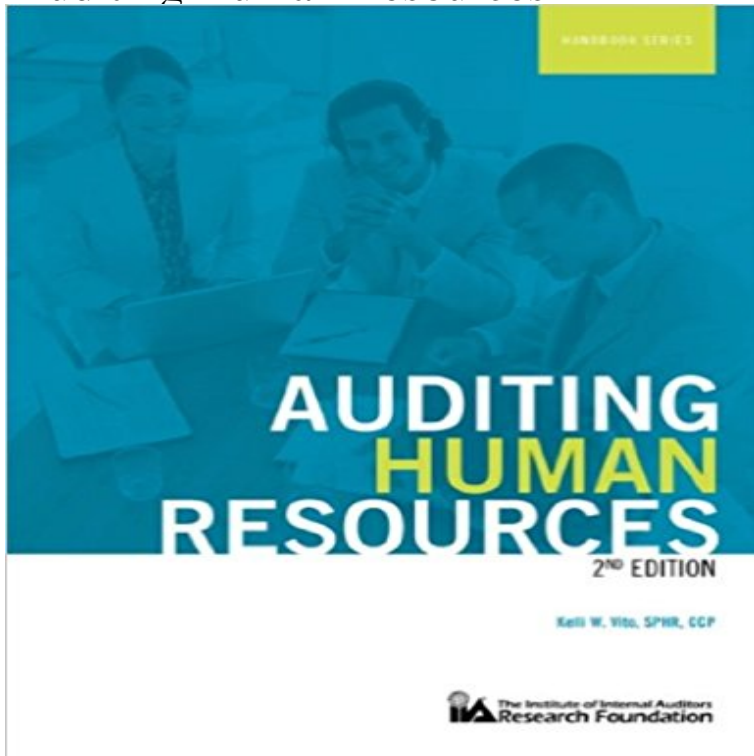


# Auditing Human Resources
