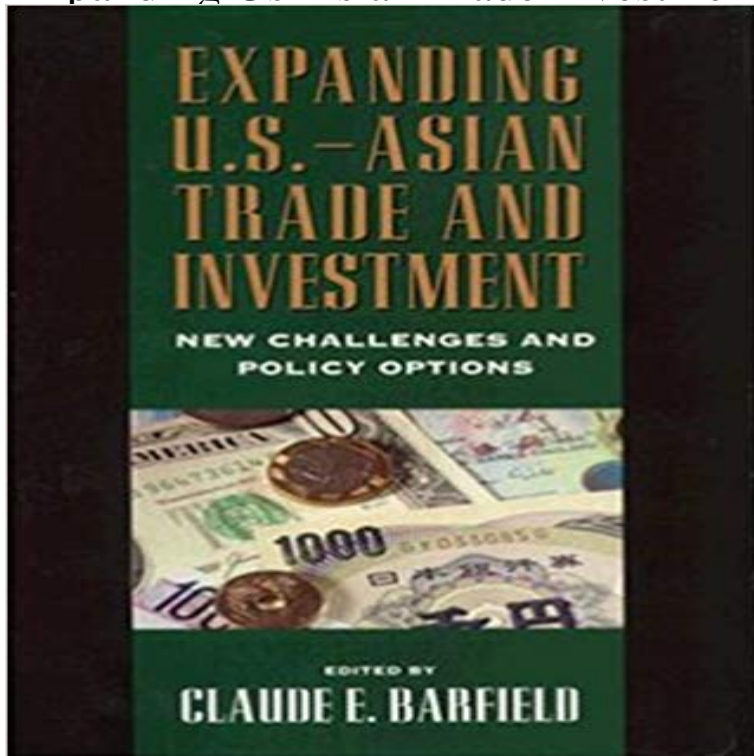


## Expanding Us-Asian Trade Investment
