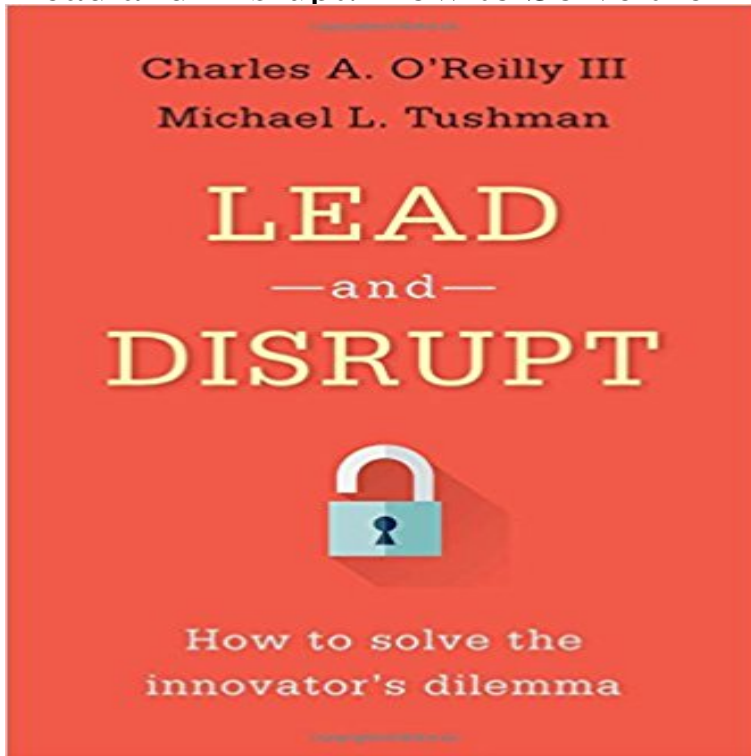


Lead and Disrupt: How to Solve the Innovators Dilemma

The authors explain how shrewd organizations have used an ambidextrous approach to solve their own innovators dilemma.
