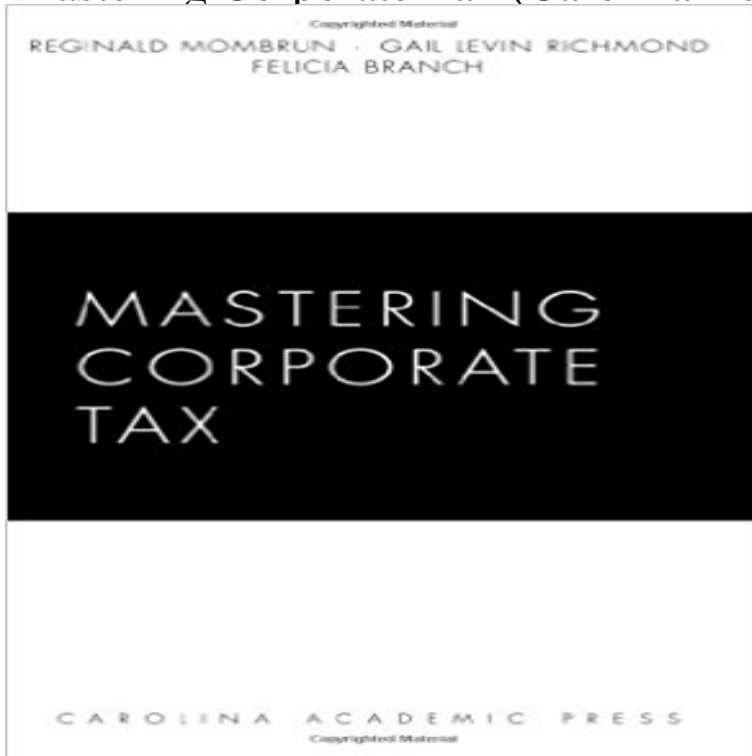


Mastering Corporate Tax (Carolina Academic Press Mastering)
