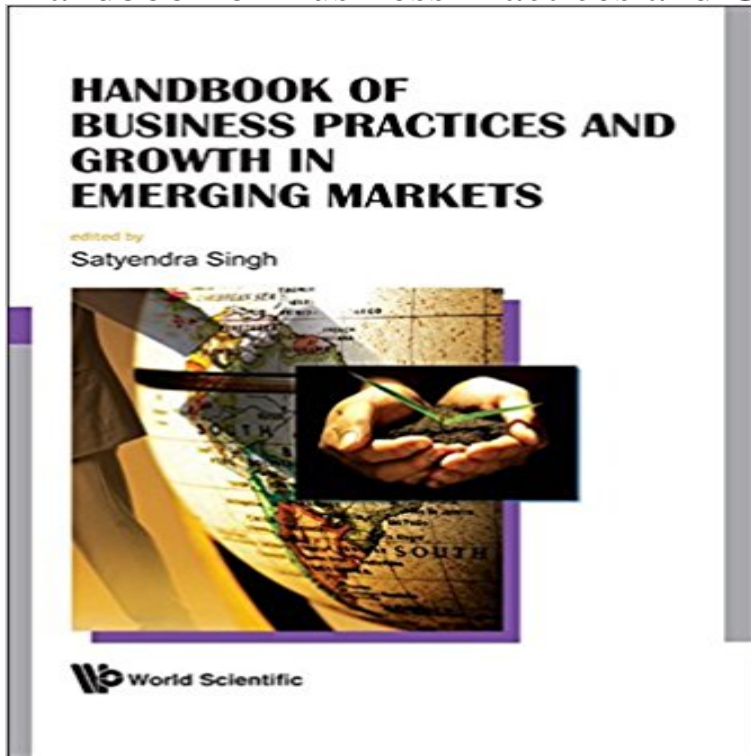


# Handbook of Business Practices and Growth in Emerging Markets
