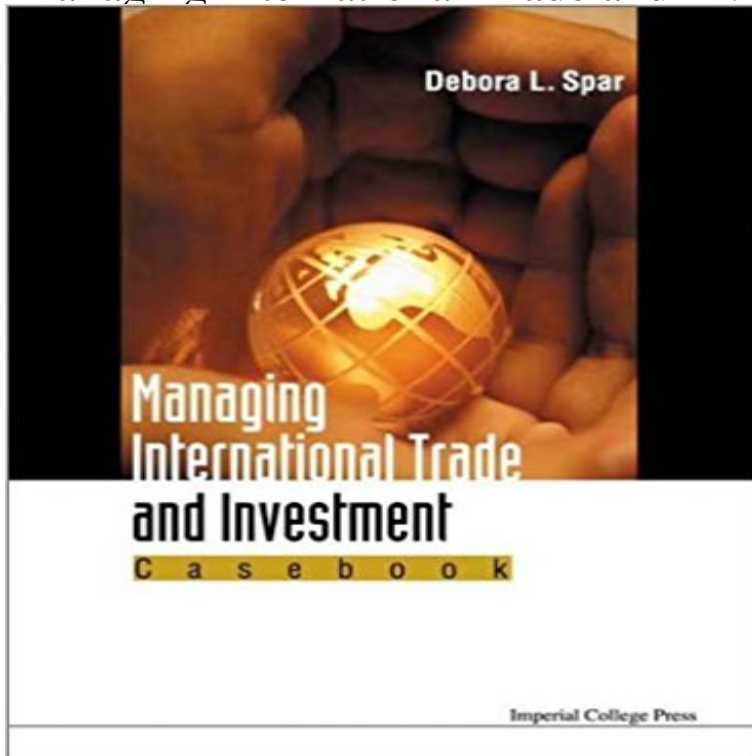


# Managing International Trade and Investment: Casebook
