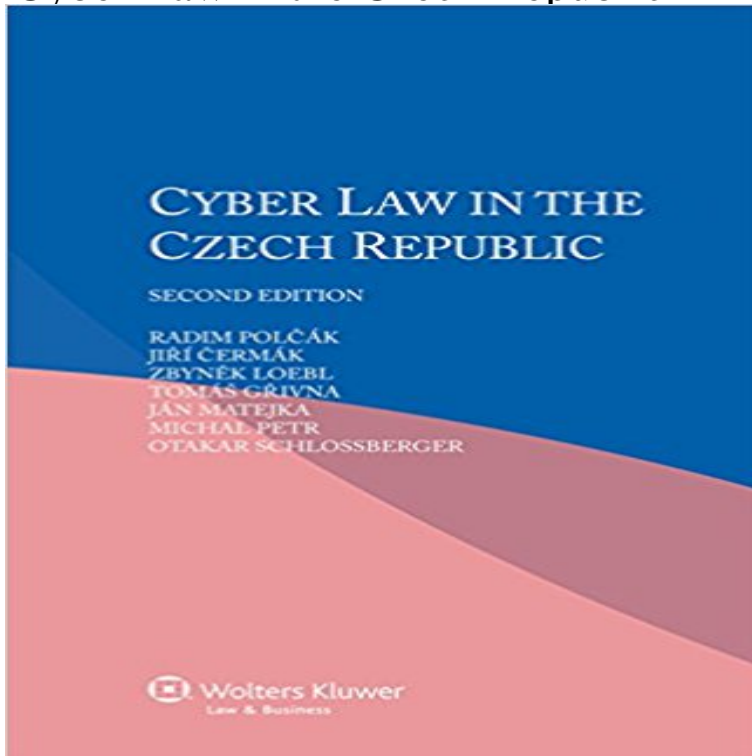


## Cyber Law in the Czech Republic
