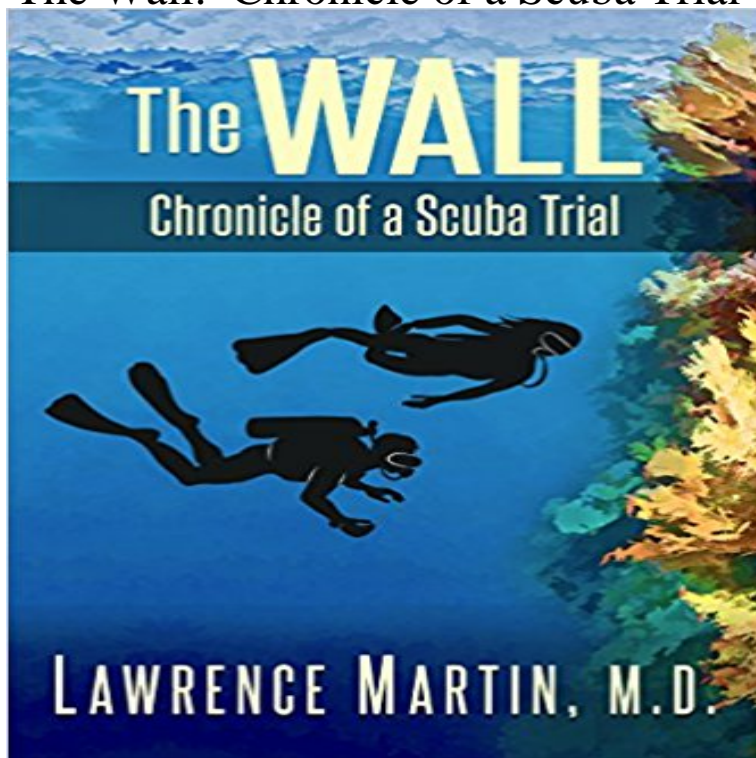


## The Wall: Chronicle of a Scuba Trial
