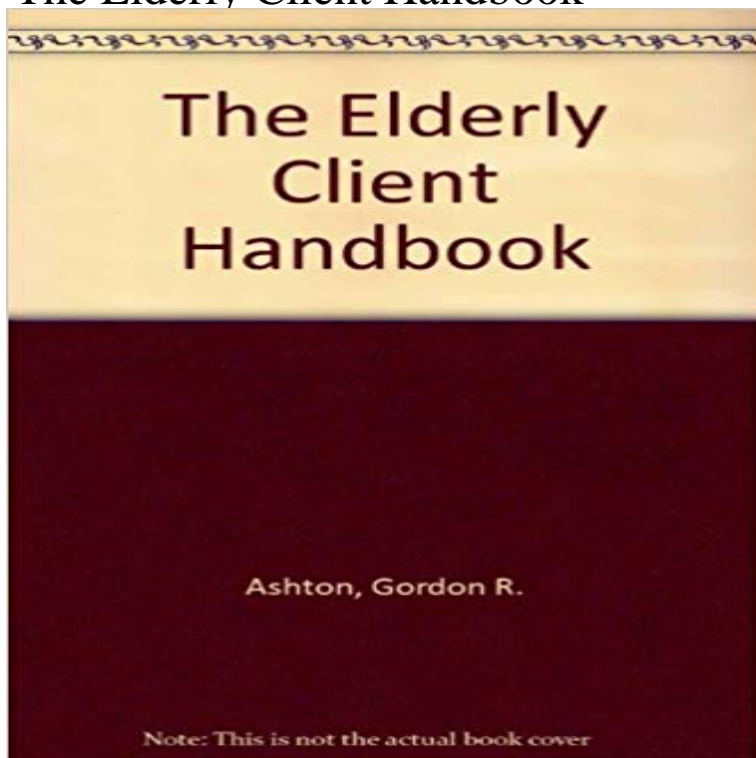


The Elderly Client Handbook
