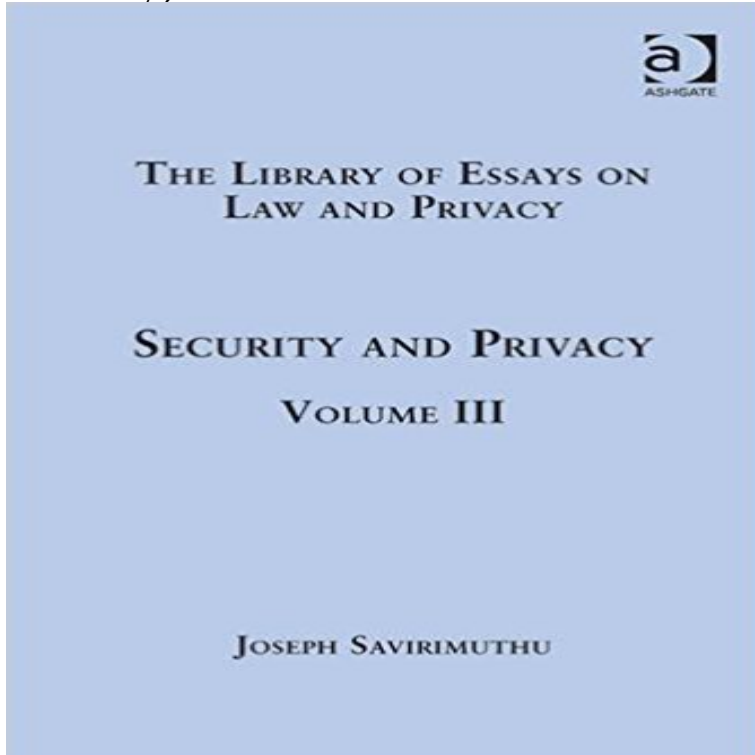


Security and Privacy: Volume III (The Library of Essays on Law and Privacy)
