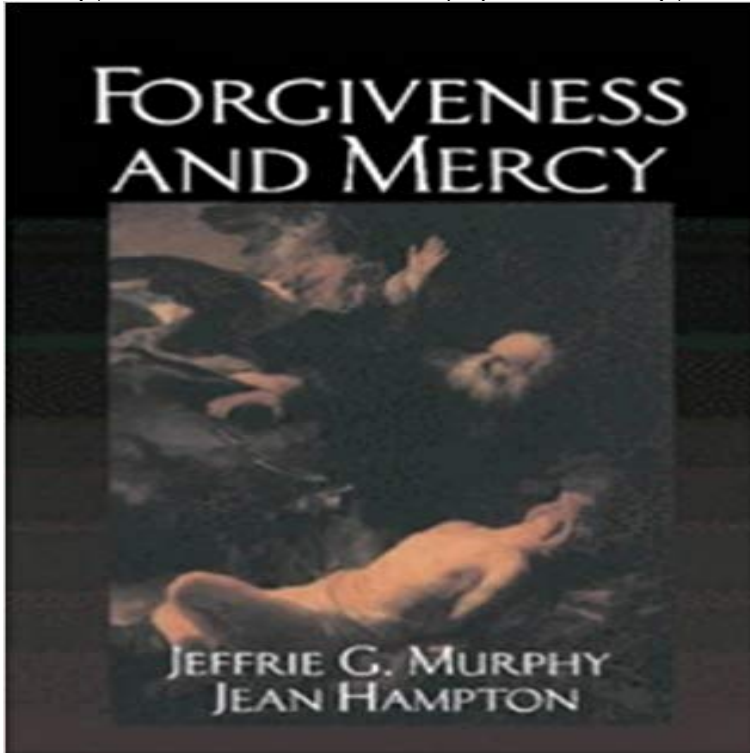


Forgiveness and Mercy (Cambridge Studies in Philosophy and Law)



This book focuses on the degree to which certain moral and legal doctrines are rooted in specific passions that are then institutionalized in the form of criminal law.
