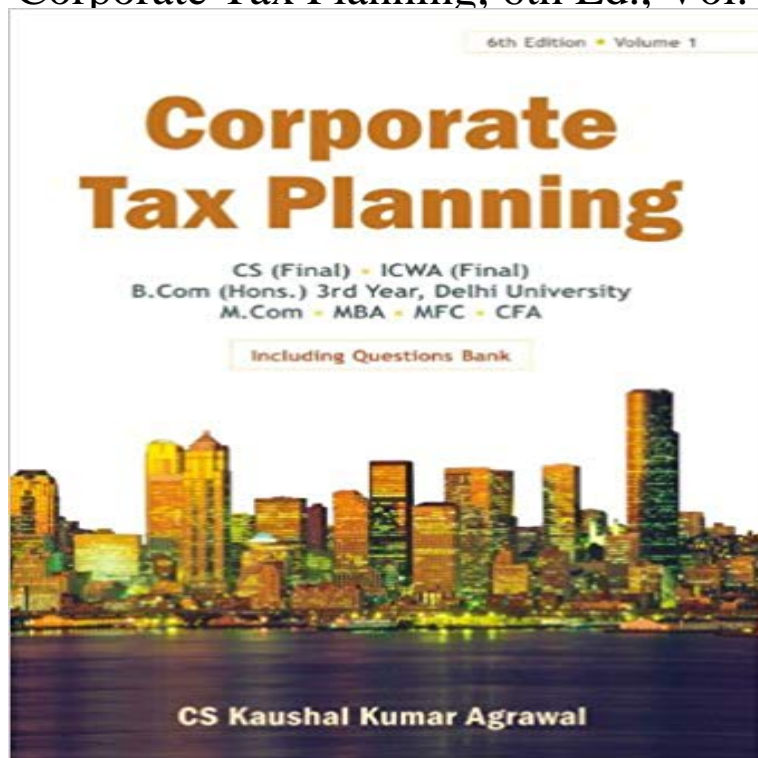


## Corporate Tax Planning, 6th Ed., Vol. 1

Now it is entitled Corporate Tax Planning and has 46 chapters divided into eleven self-contained units: Basics; Tax Planning of Salary; Tax Holiday; Profits and Gains from Business or Profession and Capital Gain; Corporate Tax in India; Financial Decisions; Setting up of New Business; Managerial Decisions; Tax Planning Others; Corporate Restructuring; and Non-Residents Taxation. The book comprehensively covers the latest syllabus prescribed by most of the Indian universities. In addition to the detailed explanation of each of its topics, the book is rich in illustrations and practice exercises that facilitate easy understanding and quick revision of the subject. The book will undoubtedly prove useful to the students of B.Com., CS (Final), ICWA (Final), M.Com., MBA, MFC and CFA.
