

Economic Sanctions: Should American Businesses Pay for Foreign Policy Initiatives?



Increasingly, governments of the developed world, especially the United States, have used economic sanctions as a foreign policy tool to compel other countries to alter their behavior. The increasing use of economic sanctions as a form of foreign policy is not without cost, however, and that cost is borne by citizens of sanctioned countries and American businesses who find international markets closed to them, either entirely or in part. This case examines the current state of economic sanctions imposed by the United States and focuses on Myanmar and Cuba, two heavily sanctioned countries moving in somewhat different directions.
