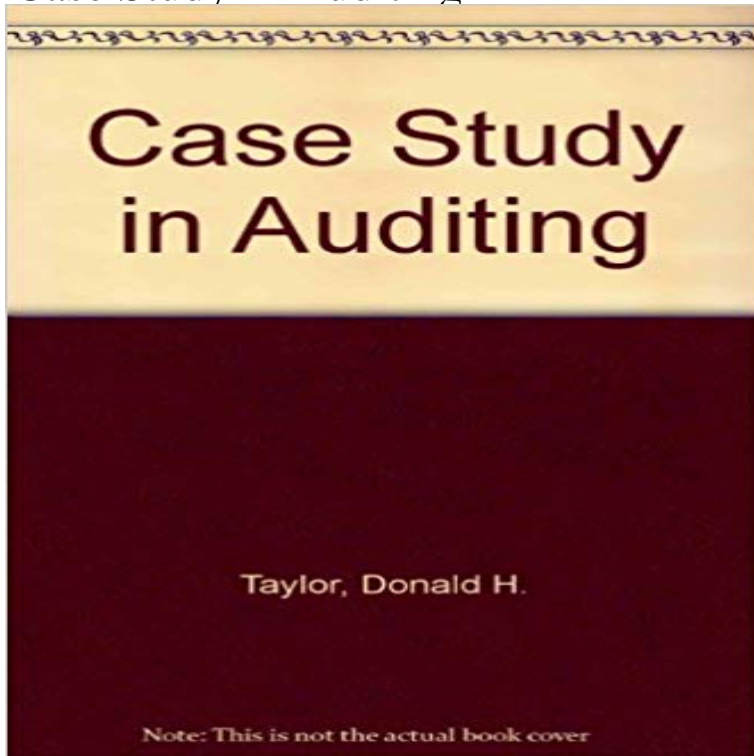


## Case Study in Auditing
