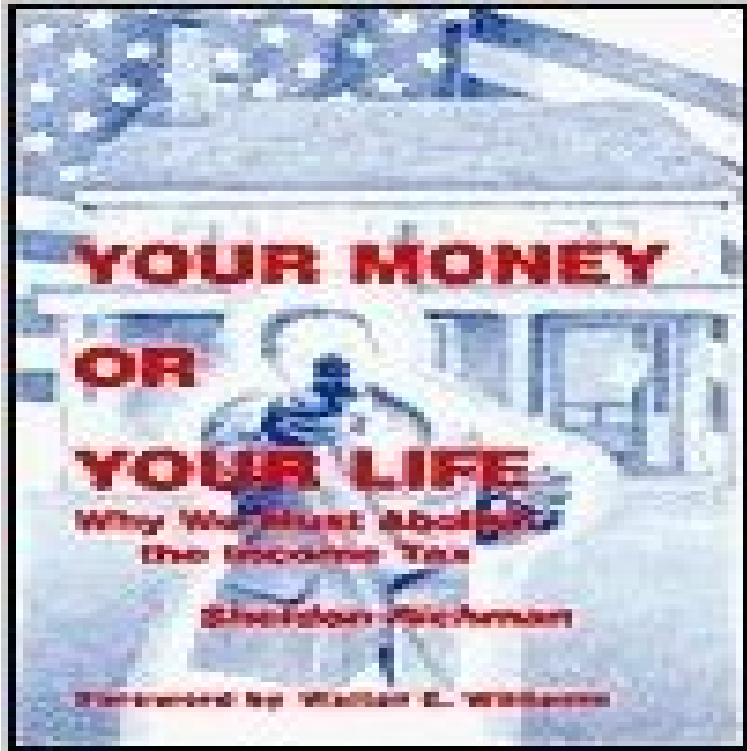


Your Money or Your Life: Why We Must Abolish the Income Tax
