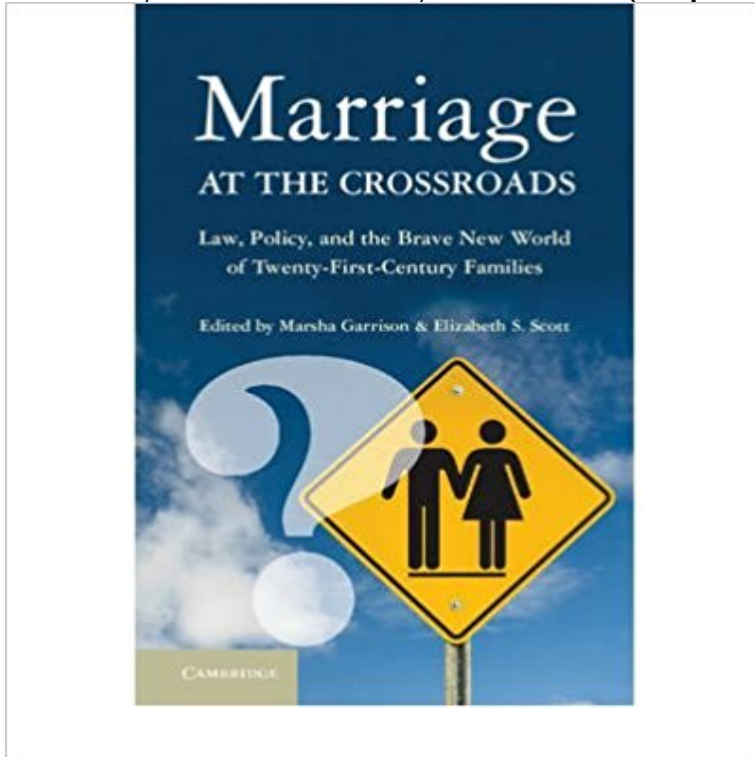


# Marriage at the Crossroads: Law, Policy, and the Brave New World of Twenty-First-Century Families (Paperback) - Common
