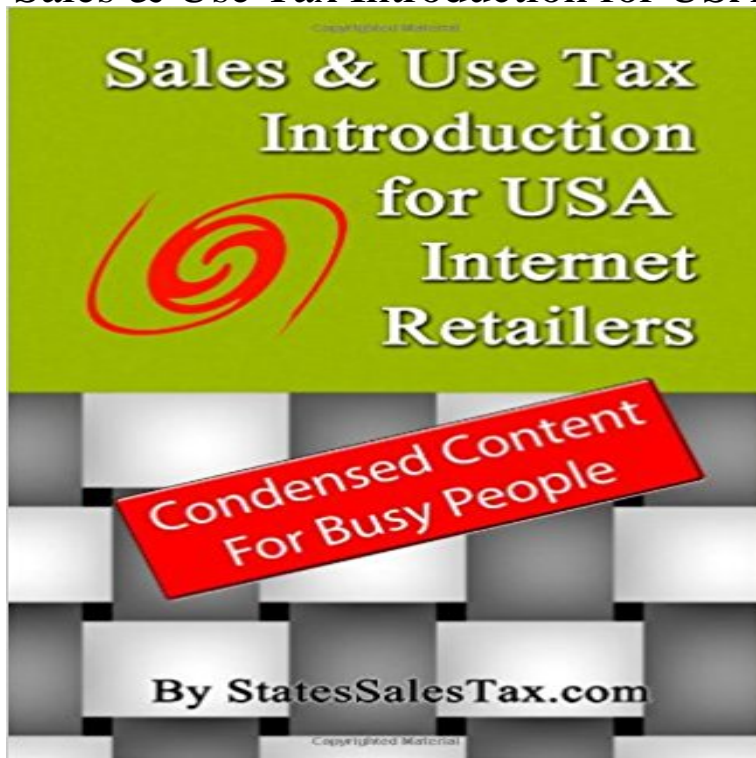


Sales & Use Tax Introduction for USA Internet Retailers
